139U *Classification of Liabilities as Current or Non-current*, issued in November 2020 amended paragraphs 69, 73, 74 and 76 and added paragraphs 72A, 75A, 76A and 76B. An entity shall apply those amendments for annual reporting periods beginning on or after 1 January 2022~~2023~~ retrospectively in accordance with SB-FRS 8. Earlier application is permitted. If an entity applies those amendments for an earlier period, it shall disclose that fact.
